

CAPTAIN RONA D. GREEN, MEDICAL SERVICE CORPS, UNITED STATES NAVY

EXECUTIVE OFFICER, U.S. NAVAL HOSPITAL/NAVY MEDICINE READINESS & TRAINING COMMAND GUANTANAMO BAY, CUBA

Captain Green is a native of Malvern, Arkansas. In July 1989, she enlisted in the Navy as a Dental Technician. During her ten years of enlisted service, she was assigned to Naval Dental Center, Newport, Rhode Island, 12th Dental Company, Cherry Point, North Carolina and National Naval Dental Center, Bethesda, Maryland. In August 1999, she was commissioned as a Lieutenant Junior Grade, Healthcare Administrator, in the Medical Service Corps through the Inservice Procurement Program.

After completing Officer Indoctrination School in November 1999, Captain Green reported to University of the Health Sciences, Bethesda, Maryland, where she served as a Recruiter. In December 2001, Captain Green reported for duty as Division Officer, Fleet Surgical Team SIX. During this assignment, she completed a 279-day deployment onboard USS NASSAU (LHA-4) in support of Operation Enduring and Iraqi Freedom.

After completing a three-year tour as Executive Assistant to the Deputy Commander, Naval Medical Center, Portsmouth, Virginia, Captain Green reported aboard as Head, Patient Administration Department, Naval Hospital, Naples, Italy. In February 2009, Captain Green was assigned to Secretary of the Navy's Office of Legislative Affairs as the Navy Legislative Liaison on Capitol Hill for medical programs. She was responsible for educating members of Congress and their staffs on the programs and policies of Navy Medicine. During this time serving the 111th and 112th Congress, her portfolio of issues included first joint DoD/VA Federal Healthcare Center, consolidation of Walter Reed and NNMC Bethesda, controlling healthcare costs, wounded warrior support and care and implementation of Medical Homeport.

From July 2012 through July 2014, she served as Director for Administration, U. S. Naval Hospital Guam and reported as Director for Administration, Naval Hospital Camp Pendleton in July 2014. After a successful tour in July 2017, Captain Green reported to Naval Personnel Command, Millington, Tennessee as Medical Service Corps Assignment Officer (Healthcare Administrator). She was assigned to Naval Medical Forces Pacific as regional Director for Administration and Specialty Leader, Healthcare Administration for over 447 officers from December 2019 through April 2022. In May 2022, she assumed duties as Executive Officer, U.S. Naval Hospital/Navy Medicine Readiness & Training Command Guantanamo Bay, Cuba.

Captain Green is a member of the American College of Healthcare Executives. Her personal awards include the Meritorious Service Medal (five awards), Joint Commendation Medal, Navy and Marine Corps Commendation Medal (three awards), and the Navy and Marine Corps Achievement Medal (four awards).
